CITING ACS REFERENCES IN-TEXT

In ACS style, you may cite references in text in three ways:

Reference Type	Example
By superscript numbers, which appear outside the punctuation if the citation applies to a whole sentence or clause.	Oscillation in the reaction of benzaldehyde with oxygen was reported previously. ³
By italic numbers in parenthesis on the line of text and inside the punctuation.	The mineralization of TCE by a pure culture of a methane-oxidizing organism has been reported (6).
By author name and year of publication in parentheses inside the punctuation (known as author-date).	The primary structure of this enzyme has also been determined (Finnegan et al., 2004).

In all three systems, the author's name may be made part of the sentence.

The syntheses described by Fraser⁸ take advantage of carbohydrate topology.

Jensen (3) reported oscillation in the reaction of benzaldehyde with oxygen.

According to Harris (2003), drug release is controlled by varying the hydrolytic stability of the ester bond.

⇒ Whenever authors are named, if a reference has 2 authors, give both names joined by the word "and". If a reference has more than two authors, give only the first name listed, followed by "el al."

⇒ To cite more than one reference by the same principal author and various coauthors in one of the numerical citation systems, use the principal author's name followed by "and co-workers" or "and colleagues".

⇒ When citing more than one reference at one place by number in one of the numerical systems, list the numbers in ascending order.
